### **Saving Gummun Place**

Dear Rebecca

The Merriwa District Progress Association (MDPA) would like to ask for your assistance to help secure the future of Gummun Place Aged Care Hostel in Merriwa NSW. The Upper Hunter Shire Council (Council), who currently operate the facility, has begun a transition process to hand the operation of the hostel to another operator, or alternatively to close the doors permanently if another operator cannot be found.

The community of the Merriwa district is appalled by Council's decision, as Gummun Place is recognised as a vital service for the district's ageing community.

### **History**

In the early 1990's, the community raised enough funds and applied for grants to establish Gummun Place as a hostel for the aged residents in the district who were unable to care for themselves at home but were not unwell enough to require hospitalisation. A local businessman donated the land on which Gummun Place now sits. Consequently, the community believes the ownership of Gummun Place lies in the hands of the community. A Trust was set up to manage the facility, and the (then) Merriwa Shire Council appointed as Trustee. Upon Councils' amalgamation in 2004, the Trusteeship was transferred to the Upper Hunter Shire Council to manage and operate Gummun Place.

To the blind satisfaction of the local community, Council managed Gummun Place effectively and efficiently until 2019, when it declared its intention to devolve itself of Gummun Place. The violent objections raised by the community and the lodgement of a 600 signature petition to preserve Gummun Place, caused the Council to halt its path down this course of action. However, on occasions since that time, Council has held confidential meetings to discuss the future of Gummun Place, and has kept the community in the dark about their discussions.

### **Current situation**

In November 2024, Council announced its intention to advertise for authorised aged care providers to take over Gummun Place, either by management, lease, or purchase of the facility. The MDPA called a public meeting, which was extremely well attended by concerned residents, and at which the community expressed its outrage that Council would consider closing Gummun Place.

Council engaged a consultant (Pride Aged Living) to seek expressions of interest (EOI) from authorised aged care providers, however no firm expressions of interest were received.

On analysing Council's financial statements on income and expenditure, it has been found that the cost of operating Gummun Place has increased significantly, as the table below shows. Regrettably, accurate financial figures for Gummun Place are not available for periods earlier than that shown below.

Anecdotal evidence suggests that Council has been mismanaging Gummun Place, some say in a ploy to prove that the facility is a burden to ratepayers. For example, available Council records (above) show that only \$131,731 was expended on capital items over the past three years. Further, the cost of staffing and general expenses has increased markedly over the same period of time. We understand that this is partially due to the use of 'agency staff' instead of locally based carers. At present, there are six or seven agency staff engaged at Gummun Place, costing around \$270,000 each per annum, for hourly fee (\$85), travel allowance (\$1,200 per return trip) and accommodation (\$160 per night). Local staff are only paid around \$30 per hour and do not incur costs for travel or accommodation, but have had their working hours reduced and refused permanent employment.

In a public meeting arranged by Council's new Gummun Place Hostel Advisory Committee, Council advised that it has applied to the Department of Health and Aged Care (in 2023, 2024 and 2025) for a grant of \$2,000,000 to carry out essential works on Gummun Place so that it meets the standards required of an aged care hostel. We believe this is due to the fact that Council has failed to maintain the facility to a satisfactory level required of an aged care hostel.

Therefore, we are not surprised that there were no expressions of interest from authorised aged care providers to take over a facility that requires \$2 million of repairs and upgrades and is costing an increasing amount to operate.

Needless to say, the community is very disappointed with the way Council has been mismanaging Gummun Place, but agrees that (now) Council may not be the most appropriate organisation to operate Gummun Place. Therefore, instead of Council seeking an increase in its annual subsidy from the Department of Health and Aged Care, the MDPA asked Council at a recent ordinary meeting to secure a grant or borrow money to carry out essential works on Gummun Place, and to review its increasing expenditure to bring it under control. That way, the facility would appear more attractive to an approved aged care provider to assume operation. Council has not responded to this request, but instead offered to hand the facility back to the community in its current poor financial state.

## How you can help

The previous Minister, the Hon Anika Wells MP connected the 'Local Network' section of the Department of Health and Aged Care with the MDPA earlier this year. Several 'on-line' meetings have taken place, and the advice provided by the members of this section has been most informative. However, as Council is the authorised aged care provider for Gummun Place, the Department has been unable to discuss specifics of this case or to take any appropriate action.

Congratulations on your recent appointment as the Assistant Minister for Health and Aged Care. We note the Federal Government's work to build a high-quality, respectful and sustainable aged care system.

In concert with this ideal, we would like to ask you to apply any influence you may have to encourage the Department of Health and Aged Care to approve Council's current application for a \$2m grant to restore Gummun Place to a suitable standard.

We would also be pleased if you would discourage Council from dispassionately disposing of this essential facility in a 'fire sale' to a private organisation (as we believe it belongs to the community).

Naturally, we would be grateful for any other influence you could exert on appropriate parties to secure the future operation of Gummun Place.

The long-term future of Gummun Place is of the highest importance to the community of Merriwa and district, so we are seeking assistance and compassion in our attempts to secure this essential facility for our local ageing population.
